The NAA’s annual Fun Auction event, held during C&S, has a new name and format.

In a survey conducted last fall, attendees indicated an interest in a shorter version of the current Fun Auction event, so they can enjoy an evening out on the town.

A new event, Auction and Appetizers, was born! The auction will begin at 4:30 p.m. and end at 6:30 p.m. on Wednesday. There will be a live and an online auction. In order to keep the auction to two hours, the live auction is limited to 40 items. All remaining donated items will be sold in the online auction. Light appetizers and beverages will be served.



At least one person from each state will be allowed the first opportunity to sell one live item. Donation information must be received by June 27. If more than one person from any particular state wants to sell at the live auction, a drawing will be conducted to determine who will sell live. Donors will be notified by June 29 as to whether their item will be sold at the live auction or online.

At the conclusion of the auction, we will have an “Open Mic” time, for about one hour. The “Open Mic” time allows people the opportunity to use the stage, briefly, to practice their chant - for example, contract auctioneers or people competing in the IAC competition. For those competing in the IAC, this is a good opportunity to get a feel for the stage, lights and sound, prior to Friday. No items will actually be sold during the Open Mic time.
